Annotated Criminal Laws of Texas 2017–19 (bound, available in August)

Case cites, practice tips, and charts based on years of questions from Texas prosecutors follow the statutes in this book, which includes the Penal Code, Code of Criminal Procedure, Controlled Substances Act, juvenile and protective order portions of the Family Code, Rules of Evidence, and Appellate Procedure. **\$74**

Code of Criminal Procedure 2017–19 and Penal Code 2017–19 (spiral, available in August)

The spiral-bound CCP and PC are the only criminal code books that feature ~~underline/strikethrough~~ format for 2017 legislative changes, commentary from prosecutors who spent their time at the Capitol, and spiral binding that allows the book to lie open flat. **\$41 CCP & \$35 PC**
