Advanced Appellate Advocacy Course

Advanced Appellate Advocacy Course Information

DCAA's Advanced Appellate Advocacy Course is designed for prosecutors who are assigned primarily to an appellate caseload or have significant mixed trial and appellate experience who want to prepare and participate in a hands-on course to increase their effectiveness in brief writing and oral argument. Upon acceptance, all participants will receive a packet of instructions and a scenario that will form the basis of the presentations, faculty demonstrations, writing, and courtroom performances.

To facilitate training in both writing and argument, this course is split into two parts. The first two days of training will occur in Austin. In part one, the focus will be on effective research and writing. Part two of the training will also last two days and will be hosted by the Baylor Law School in Waco. During the break between the two halves of training, attendees are expected to hone their brief and prepare for argument. In Waco, participants will be assigned to one of the law school's practice courtrooms with a smaller group of participants and experienced faculty advisors, who will guide the group discussions and provide critiques of each participant's live and recorded performances. Participants will have two opportunities to argue and receive personalized feedback on their written briefs and a recording of their argument.

Attendance: Attendance is limited to 20 prosecutors. All applications must be received by May 16, 2022. No walk-in registrations will be accepted under any circumstances. Upon acceptance, participants will receive confirmation, informational packets, and instructions via email. Advance preparation and full participation are required. Applicants who are not accepted for this course will be put on a waiting list and have priority in case of cancellations. Any attendee substitutions must be submitted to and approved by TDCAA.

Attire: In Austin, business casual dress is acceptable. In Waco, courtroom attire is required.

CLE: TDCAA has applied to the State Bar of Texas for 18.5 hours of MCLE credit, including 1 hour of ethics training for participation in this course.

Registration and fees: Applicants who are admitted to the course will receive a private registration link. A host hotel has been secured for both sites with enough rooms to accommodate attendees. Further information and instructions on how to book these rooms will be included in the emailed notifications of acceptance. TDCAA will reimburse attendees' hotel costs up to the GSA rate. TDCAA will not reimburse for meals, travel, registration fees, hotel tax, parking, taxi costs, or other extraordinary expenses. All other expenses are your own.
