

### 9:00 a.m. TDCAA's Cavalcade of Topics

When accusations of prosecutorial misconduct, irrespective of their veracity, become an accepted strategy, the professional rules are a shield for ethical prosecutors. Here, we separate violations of the conduct rules as written from what is mere manipulative allegation.

## Payment options:

**\$350 Registration** (\$175 Registration fee + \$175 Association fee): For CAs, DAs, CDAs, C&DAs, and their office personnel.
