### Payment options:

- ☐ **\$500 Registration** (\$250 Registration fee + \$250 Association fee): For CAs, DAs, CDAs, C&DAs, and their office personnel. The TDCAA fee of \$250 is each participant's share of costs over and above what the grant allows (for example, excess costs of on-site meals and association overhead).
