Case cites, practice tips, and charts based on years of questions from Texas prosecutors follow the statutes in this book, which includes the Penal Code, Code of Criminal Procedure, Controlled Substances Act, juvenile and protective order portions of the Family Code, and Rules of Evidence. \$74

Code of Criminal Procedure 2019–21 and Penal Code 2019–21 (spiral, available in August) The CCP and PC are the only criminal code books that feature <u>underline/strikethrough</u> format for 2019 legislative changes, commentary from prosecutors who spent their time at the Capitol, and spiral binding that allows the book to lie open flat.
