Description of Presentations

Diversions

There is widespread agreement that courts should seek to divert offenders with mental impairments to effective treatment options, public safety permitting. But what options are available? What is working? How does a prosecutor balance the needs of the public with potential treatment options for the offender?

Legal Basics

In this session, attendees will learn basic tools to navigate civil and criminal commitments from A to Z, such as assessments, emergency detention, and civil commitment. It will also include forms and procedures for civil and criminal commitments.

Mental Health 101

Prosecutors are not doctors, but it is essential that they know the basics of mental illness when they seek to address the illness in the context of a criminal proceeding.

Not Guilty by Reason of Insanity (NGRI)

A trial in which a defendant pleads "not guilty by reason of insanity" can be complex. In this session, attendees will not only learn about the trial of such a case, but also about the post-verdict procedures needed to ensure that the offender continues to receive the proper care—and the public continues to be protected.

Sequential Intercept Model (SIM)

The SIM identifies key diversion points in the criminal justice system for an offender with mental health issues and has proven successful in developing a community-based response. Using the SIM creates a strategic plan based on local resources and priorities with the goal of assisting the offender with mental health issues while protecting public safety.

State Hospital

The State Hospital is an essential tool for the system as we seek to restore competency and treat mentally ill offenders. Attendees will take a deep dive into the workings of the state hospital and its impact on cases once the defendant returns to court.
