## COMPLAINT

{Articles 15.04, 15.05, and 51.13 §13, Texas Code of Criminal Procedure}

BEFORE ME, THE UNDERSIGNED AUTHORITY, PERSONALLY APPEARED THE AFFIANT HEREIN, A PEACE OFFICER UNDER THE LAWS OF TEXAS, WHO, BEING DULY SWORN, ON OATH MADE THE FOLLOWING STATEMENTS AND ACCUSATIONS:

My name is Smokey Bruin and I am commissioned as a peace officer by the Texas Department of Public Safety. I hereby state upon my oath that I have reason to believe and do believe that heretofore, and before the making and filing of this Complaint, that

JACKSON SAMUEL "SKIP" GILMORE, w/m, d.o.b. 02/18/73

on or about the 13th day of April, 2018 in Lubbock County, Texas, did then and there flee from justice in the State of New Mexico to the State of Texas, against the laws of this State. Further, the said Jackson Samuel "Skip" Gilmore stands charged in the state of New Mexico with the crime of Burglary, in that on or about the 5th day of May, 2015 while in the State of New Mexico, the said Jackson Samuel "Skip" Gilmore committed the crime of Burglary as defined in Article 200.03 of the Revised Criminal Statutes of New Mexico, against the laws of that State and has fled from justice in said State.

My probable cause for said belief and accusation is as follows: I am a state trooper employed by the Highway Patrol Service of the Texas Department of Public Safety. On this the 13th day of April, 2014, while on patrol on U.S. Highway 82 east of the City of Lubbock, I observed a vehicle apparently exceeding the posted speed limit of 75 miles per hour. I confirmed this as the vehicle registered a speed of 89 miles per hour on the radar unit in my patrol vehicle. I pursued the vehicle and effected a routine traffic stop to address the speeding issue with the driver.

The driver, a white male in his mid 40's, produced a Texas driver's license that identified him as Jackson S. Gilmore, 45 years of age, with an address of 2304 E. 19th Avenue, Lubbock, Texas. I asked the dispatcher of the Lubbock County Sheriff's Office to check the National Crime Information Center for possible warrants for Gilmore. The reply was to inform me that Gilmore was wanted in New Mexico for the felony offense of Burglary. I asked the dispatcher to contact the New Mexico law enforcement agency that held the warrant and to confirm that it is still active and that Gilmore is in fact a fugitive. Upon receipt of the affirmative confirmation, I arrested Gilmore as a fugitive from justice pursuant to Article 51.13, Section 14 of the Texas Code of Criminal Procedure.

When I arrived at the Lubbock County Sheriff's Office with Gilmore in custody, the dispatcher delivered to me a computerized print-out of Gilmore's criminal history. Included was a narrative explaining that Gilmore was indicted in Lea County, New Mexico for the offense of Burglary in July 2015. The record indicated that Gilmore had posted bail for the indictment but had failed to return to court in accordance with the terms and conditions of his bail bond on August 6, 2012. A warrant was issued for his arrest and Jackson S. Gilmore, who the record indicates is known as "Skip," has been a fugitive from justice since that date. Through email correspondence with the State's attorney in Lea County, New Mexico, I confirmed that Burglary is a felony as prohibited by Article 200.03 of the Revised Criminal Statutes of New Mexico and it is a crime punishable by imprisonment for a term exceeding one year.

Therefore, I believe that probable cause exists to believe that Jackson Samuel "Skip" Gilmore, being charged with a felony offense in the State of New Mexico, has fled from justice in said State. Accordingly, I ask for issuance of a warrant authorizing arrest and seizure of Jackson Samuel "Skip" Gilmore for the offense of Felony Fugitive from Another State and that he be dealt with as the law provides.

It also provides that "a certified copy of the sworn charge or complaint and affidavit upon which the warrant is issued shall be attached to the warrant."]
