You are listed as a complainant (victim) in this case. I am the Victim Assistance Coordinator assigned to assist you. I can help you with information about the status of your case, with completing paperwork, and can accompany you to court. Please call or email me if you have any questions or if I can be of assistance.

Your rights as a victim/complainant in the case listed above are important to Harris County District Attorney's Office ("HCDAO"). We know that you did not ask to be a crime victim, and are committed to helping you with compassion and care during what may be a very difficult time. Please keep in mind that the HCDAO represents the State of Texas in court proceedings, as a violation of Texas law has occurred. The HCDAO does not represent you personally, nor any legal guardian or close relative associated with the case.

The defendant or someone on the defendant's behalf may try to contact you. You do not have to speak with anyone representing the defendant. If the defendant or someone representing the defendant threatens you or tries to intimidate you, please contact law enforcement and the prosecutor assigned to your case.

Important Information To Be Completed by You:

Victim Impact Statement (VIS)

The Victim Impact Statement is a form you may complete that describes the financial, physical, and emotional impact the crime has had on you. Texas Crime Victims' Compensation (CVC)

The Texas Crime Victims' Compensation Fund is a program administered by the Office of the Attorney General that may provide financial assistance such as counseling expenses, medical services, and lost wages to victims of violent crimes. To complete an application, please follow this link:

Crime Victims' Compensation Program

Victims of sexual offenses have the right to request that the judge order the defendant to undergo medical testing for sexually transmitted diseases (including HIV). Please complete

the attached HIV/STI TESTING REQUEST form if you choose to exercise this right and return with your Victim Impact Statement.

Victims of sexual offenses also have the right to payment for a forensic medical exam and for any prescribed continuing medical care that is related to the sexual offense and provided to the victim during the 30-day period following forensic medical examination.

If the victim in this case is a child under the age of 18, please complete the attached <u>CHILD NOTIFICATION AND CUSTODY FORM</u> and return with your Victim Impact Statement. The form may or may not apply to your situation.
