#### A letter from the TDCAF Board President

G reetings! My 40-year legal career offered a unique perspective into the life of a prosecutor. As the only person who has held the positions of both the Harris County District Attorney and United States Attorney for the Southern District of Texas, I know firsthand how important training is for prosecutors.

Justice is best served through the work of highly trained, ethical prosecutors. My experience demonstrated that great prosecutors who represent both our nation and state have had the best training possible in trial techniques, current law, and ethical conduct. The Texas District and County Attorneys Foundation stands in a unique place to achieve this objective. Supported by current and former Texas prosecutors, the Foundation seeks financial support for the training and professional development of both new and seasoned attorneys.

To that end, in 2021 our Prosecutor Management Institute (PMI) trained dozens of supervisors and elected prosecutors. With a curriculum built from the ground up and unique to Texas, this course addresses leadership within a prosecutor's office.

TDCAA also continued to offer both online and live courses, producing new content in both formats. To develop more online training, a new assistant training director, Gregg Cox, was hired in late 2021. As a result, we have two full-time attorneys on staff, one for live conferences (Training Director Brian Klas) and Mr. Cox for virtual formats. This addition will also make it easier for attorneys to earn continuing legal education credits.

In 1935, Justice George Sutherland in *Berger v. United States* wrote that a prosecutor must use every legitimate means to bring about a just conviction. I look forward to working together to achieve this goal.



# What TDCAF does

A fter two harrowing years of a pandemic, lockdowns, and a seismic shift in how many people do business, it's clear why the Foundation is so important to the mission and purpose of the Texas District and County Attorneys Association (TDCAA).

TDCAA is the professional association for Texas prosecutors, and it has been around for more than 100 years. Our 6,505 members—a number that swells every year—include prosecutors, investigators, support staff, defense attorneys, judges, and law students, and they need training, technical assistance, and other help in seeing that justice is done. Without effective advocates both in and outside the courtroom, crime victims and members of the public will not get the justice they deserve.

Grants support a portion of the training we produce, and



the number of prosecutors and staff who need it is always increasing. (See the chart at left for a breakdown of where we get our funding.) Without money from other sources, such as the Foundation, TDCAA could not meet the needs of its members and law enforcement. Read on to find out how we served Texas prosecutors and staff in 2021.

# What TDCAF did in 2021

# **Live and Online Training**

Normally, TDCAA produces more than 60 (!) in-person conferences a year all over the state to provide 7,000-plus people more than 50,000 hours of continuing legal education. That's a lot—these numbers rank us among the top out of more than 1,500 CLE providers. But the COVID-19 pandemic and subsequent lockdown curtailed our regular business of putting on live courses for part of the year. We quickly pivoted to producing courses that could be watched online (both live and pre-recorded), including our Legislative Update for the first time ever. Here are the training numbers for 2021:

We received such enthusiastic feedback on both live and online courses that we applied for and received grant money to hire another staff attorney dedicated solely to producing online training. Gregg Cox, our new Assistant Training Director, came on board near the end of the year, and he has hit the ground running.

# Advanced Prosecutor Training

To fight for victims of crime, prosecutors must be prepared to be at their best in the courtroom. To this end, and through a gift from the Harris County District Attorney's Office, the Foundation can sustain two critical TDCAA courses. Both are staff- and resource-intensive, and financial support from the Foundation is critical.

**Train the Trainer.** Since 2008, the Texas District and County Attorneys Foundation has fully funded the food, lodging, and training of those attending this week-long seminar at no cost to their offices. Highly qualified faculty teach prosecutors, investigators, and staff the principles of adult learning techniques so they can give more effective oral presentations to a room of their peers or a jury panel. Attendance is by invitation only, and it is limited to 32 participants.

Advanced Advocacy Courses. Here, seasoned prosecutors further their skills in an intensive, week-long session at Baylor School of Law in Waco. Through presentations, demonstrations, and directed workshops in real courtrooms, experienced faculty guide participants through detailed felony case scenarios. This course addresses many challenges that arise in the most difficult cases we try. TDCAA offers both trial and appellate advocacy so that prosecutors with different specializations can enrich their skills. These courses are limited to 40 hand-selected students and are fully funded by the Foundation so there is no cost to attendees or their offices.



## Prosecutor Management Institute (PMI)

The Texas Prosecutor Management Institute (PMI) continues to offer its bedrock module, Fundamentals of Management. This 2½-day course is designed to give prosecutors the personal insight and tools they need to successfully lead their teams. The concepts we cover translate to all prosecutors, whether they are running their first court, overseeing a cadre of attorneys and administrative personnel, or even operating as a solo elected prosecutor with responsibility for an entire county's caseload.

To date, the course has been delivered to more than 165 supervisor-level prosecutors. Other counties are currently scheduled, and even more offices have expressed a desire to attend the course. We have even offered two "elected editions" of this course exclusively to elected county and district attorneys; they have been well-attended—see some photos from December 2021's course below.

# **Publications**

Another key to educating prosecutors, especially in a year with so few opportunities for networking and in-person gatherings, is publications. In 2021, TDCAA provided six grant-funded criminal law books for prosecutors and law enforcement officers. TDCAA publishes more than 30 books and manuals in all, including electronic versions of code books, to educate prosecutors and staff on a wide breadth of criminal law topics. The Foundation has been instrumental in getting many of these publications into the hands of the professionals who need them.

# **Victims Services**

The Foundation helps underwrite our Victims Services Director position to improve legislatively mandated but largely unfunded crime victim services in prosecutor's offices. TDCAA's Victim Services Director, Jalayne Robinson, provides training to individuals and groups on topics related to victim services and crime victims' rights. Jalayne is available daily for TDCAA members who need technical assistance via phone or email.

In 2021, Jalayne:

• presented victim services training to 780 victim services personnel, prosecutors, and prosecutor office staff at TDCAA courses, including two Prosecutor Skills Trial Courses, the Key Personnel & Victim Assistance Coordinator Conference, and the Annual Criminal & Civil Law Conference;

• provided trainings for groups and individuals, in person, online, and via Zoom teleconferences (as in the photos on the opposite page);

• provided ongoing daily email and telephone support to VACs and prosecutors;

• served as project director for our Office of the Governor Criminal Justice Division VOCA grant, including grant writing and grant administration;

• assisted in developing VOCA grant training;

• helped coordinate TDCAA's Key Personnel—Victim Services Board, including conducting elections and meetings and corresponding with board members;

• wrote a regular column for TDCAA's journal, *The Texas Prosecutor;* 

• moderated discussion forums online and at the Annual Criminal & Civil Law Conference; and

• represented TDCAA in policy development and service coordination with state agencies and other nonprofits assisting victims.

All told, 2021 was a busy year that supplied Texas prosecutors and staff with the high-quality training they need—and it kept us on our toes!

# Texas Prosecutors Society (TPS)

n 2011, under the direction of then-Board Chair Dan Boulware and Endowment Chair Tom Krampitz, the Foundation established a select group of supporters called the Texas Prosecutors Society. This invitation was for those who have demonstrated an interest in and commitment

to improving prosecution and training in Texas, whether they serve as current prosecutors, criminal defense attorneys, or judges; they practice in another area of law; or they are enjoying retirement. We are proud that so many current and former prosecutors have joined these ranks.

TEXAS HROSECUTORS SO

Texas Prosecutors Society members have pledged \$2,500 each to create an endowment fund for the Foundation—a forward-thinking strategy for building stability and growth for both the Foundation and the Association. The endowment's purpose is to collect and invest funds for the future to provide critical support to the Association.

Each year, new Society inductees are recognized at a special reception at TDCAA's Elected Prosecutor Conference in December. In 2021, we celebrated two new classes (because 2020's reception was cancelled due to COVID), bringing the number of TPS members to 229. (See the photo below for those in the Class of 2021 who attended.) It will continue to grow as more prosecutors and alumni are invited to join every year. # Escamilla-Wortham Challenge

A few years ago, the Texas Legislature amended Code of Criminal Procedure Art. 59.06(d-2) to allow elected prosecutors to donate these funds to an entity that provides training or education related to the detection, investigation, or prosecution of a crime or abuse. We are grateful for these contributions (when local needs have already been met) and have committed that all such funds are "restricted"—meaning, they are used only for training, without any expenditures for Foundation overhead and the like.
